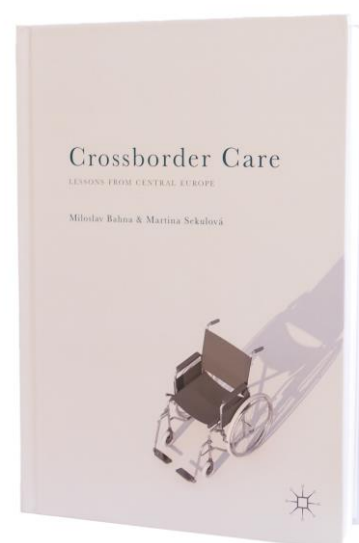

1.8. Summary of R&D activity pursued by the institute during the evaluation period in both national and international contexts. The evaluation period was characterized by a **major push of the Institute towards international visibility and relevance** while maintaining its position as a flagship provider of national research and expertise in the field of sociology in Slovakia. Our expertise and research continue to enjoy a very high visibility as demonstrated by hundreds of media mentions and appearances with a clear social impact demonstrated in the case studies presented in part 2.6. Researchers from the Institute are also increasingly visible at international conferences and academic events. In 2016, the Institute admitted its first PhD students since its renewed accreditation for PhD studies obtained in 2015. Providing an annual PhD lecture series, the Institute collaborates with its university partners at Comenius University in Bratislava and Trnava University in Trnava and currently hosts **the largest sociology PhD programme in Slovakia**. The position of the Institute is also visible in its ability to attract international scholars, who frequently choose our Institute as the host institution for their Individual Marie Skłodowska-Curie projects, SASPRO fellowships and other international exchanges (e.g. SAIA fellowships).

The drive towards establishing the Institute as a major player in the discipline can be demonstrated by the **growing share of publications in globally relevant publication outlets**, be it monographs at established academic publishers (Routledge, Palgrave Macmillan) or major international journals in the field. The English language monographs published at major academic publishers include works by the Institute's core researchers as well as by long-term collaborators, especially Marie Skłodowska-Curie / SASPRO research fellows. Within this growing collection of publications written in English few titles particularly stood out. *Crossborder Care: Lessons from Central Europe* (Palgrave Macmillan 2019) by Miloslav Bahna (with Martina Sekulová) was the first to extensively cover the topic of crossborder care between Austria and Slovakia as a special case of the commodification of care. The book has been awarded the status of an outstanding monograph by the Slovak Academy of Sciences and was deemed to be among the best sociological works of 2020 in the Alexander Hirner competition. The monograph *Sociology of Crisis: Visualising Urban Austerity* (Routledge 2017) by Myrto Tsilimpounidi, has been listed as a 'leading handbook in the field' in the Routledge 'Advancements of Sociology' series. The publication was awarded the 2017 Prize for the Popularisation of Science by the Slovak Academy of Sciences.



Our scholars have an excellent track record in **publishing first- or single-authored articles with top-tier journals**, such as *Acta Sociologica*, *European Journal of Industrial Relations*, *European Sociological Review*, *European Societies*, *Focaal*, *Gender, Place and Culture*,

International Migration review, Journal of Cultural Economy, Qualitative Inquiry, Social Anthropology, Social Politics, Work, Employment and Society, and others. Within this growing collection we are particularly proud of the paper “Does the freedom of information law increase transparency at the local level? Evidence from a field experiment” published in *Government Information Quarterly* in 2018. The study, the first of its kind in Slovakia, focuses on the question of whether freedom of information laws increase transparency at the local level. The paper’s uniqueness lies in the fact that it studies all the municipalities in the country. One of the most cited 2018 articles of the *Population, Space and Place* journal, “Study choices and returns of international students: On the role of cultural and economic capital of the family” examines the interplay of cultural and economic capital in the post-graduation career paths of international students from Slovakia. Another example of our contribution to international debates in the field of Sociology is the 2020 study “Explaining the role of international scholars in semi-peripheries. Evidence from Slovakia” published in *Studies in Higher Education*. This paper explains the mechanisms behind the internationalization of Slovak universities. Co-authored with a visiting scholar at the Institute, this paper represents the results of international collaboration based on exchange stays at the Institute funded by the SAIA agency.

The institute also **maintains its leading position nationally** by publishing in Slovak, while continuing to increase its international visibility with **a high and growing share of English-language publications**. Our principal outputs therefore include Slovak language monographs which are the results of international cooperation or are important syntheses of long term processes of societal transformation. The book based on the European Values Study *Oddelené spolu?: Česko a Slovensko optikou vývoje hodnot po roce 1991 [Living apart together? Czechia and Slovakia through the lense of value development after 1991]* edited by Ladislav Rabušic, Zuzana Kusá, Beatrice Chromková Manea, and Katarína Strapcová (Slovart, 2019) provides the first systematic comparison of the development of values orientations related to family, work, religion, solidarity, politics and the public sphere in Czechia and Slovakia since the split of the common state. The majority of its chapters are co-authored by Slovak and Czech sociologists, who analyse data from four European Values Study surveys (1991, 1999, 2008 and 2017) in both countries. An important aspect of free market transformation - the conversion of cooperatives in the Slovak agriculture sector - is dealt with in the award winning monograph by Jana Lindbloom (winning both the Alexander Hirner prize of the Slovak Sociological Society and the Literary fund award) *Transformácia a zánik poľnohospodárskych družstiev [The Transformation and Fall of Agricultural Cooperatives]* published in 2019 by the VEDA publishing house of the Slovak Academy of Sciences.

The 2016 monograph *Sídelný vývoj na Slovensku (1990-2014) a jeho sociálno-priestorové kontexty a dopady [Settlement development in Slovakia (1990-2014) and its social-spatial contexts and implications]* by Peter Gajdoš and Katarína Moravanská represents another example of a synthesis of long term research at the Institute. The most important contribution is the examination of social, cultural and demographic factors that affect regional development in all regions and all settlements in Slovakia in a period of more than 20 years. This results in a social settlement typology of municipalities, which demonstrates significant settlement and regional differentiation in Slovakia.

The **institute’s own Sociológia journal** is also used as a publication outlet of researchers at the institute, whether in its Slovak or English language issues. However, the journal is more than an in-house publisher: it successfully attracts authors from other regional and international institutions, steadily increasing its position in international rankings and competitiveness. Papers co-authored by institute fellows constitute only 7.9% of the papers published in the evaluation period. Another evidence of the growing profile of the journal is visible in the constantly increasing number of submissions with an average of 110 submitted papers per year (the only exception was the pandemic year 2021). Approximately 30% of these were written by scholars from Slovakia – either in Slovak or in English. Thus, most of the submissions are from abroad, which shows that the journal is a recognized platform for sociologists and other social scientists in the Central European region with the largest contribution coming from Czech scholars amounting to almost 30% of submissions (with manuscripts either in Czech or in English). Other scholars who have published in *Sociológia*

in the evaluation period have been from Poland, Germany, Romania, Serbia, Lithuania, Spain and the Netherlands, but also from Argentina or South Africa. On average, there are around 26 studies published per year. Thus, the rejection rate is fairly high, at around 76%. Without over-emphasising the IF metrics, it can be noted that the impact factor of *Sociológia* has been rising steadily, **surpassing other sociology journals from the region**, with its all-time high of 0.796 in 2019. Currently, for 2021, it stands at 0.635. *Sociológia* therefore represents a journal with both national and international impact far beyond the Institute, not only in the field of sociology but also in related disciplines such as political science, geography, or anthropology.

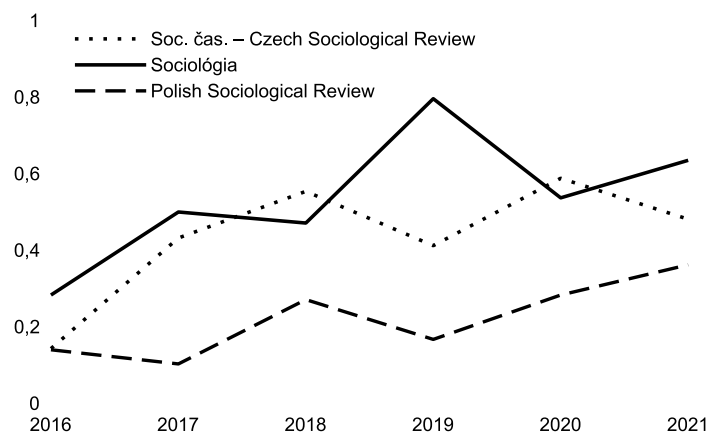
The Institute has continued its **international cooperation in the field of comparative sociology** through its active participation in the International Social Survey Programme (ISSP, <https://issp.org/>) and the European Values Study (EVS, <https://europeanvaluesstudy.eu/>).

The Institute is a long-term representative in both cooperations (1995 ISSP, 1999 EVS), which serve as bases for international project and publication collaboration within the region and internationally. Beyond fielding the national

representative surveys, as a member of the respective “Drafting Group”, the Institute was actively **involved in questionnaire development for the ISSP modules** of Family and Changing Gender Roles V (in 2019 to 2021) and National Identity & Citizenship (in 2020 to 2022). The Institute has also been a **member of the ISSP Standing Committee** (from 2016 to 2021) and the host of the ISSP 2022 drafting group meeting in 2020. In June 2022, the Institute hosted the ISSP general meeting in Bratislava and is a member of the Council of Program Directors of the European Values Survey. Besides comparative research under the auspices of major international cooperations, several joint Slovak and Czech surveys were conducted on the occasion of important anniversaries in the 2016 to 2021 period. These surveys were devoted to exploring the opinions and attitudes towards significant historical events and personalities in Czechoslovak history including the centennial of Czechoslovakia, eighty years since the Munich Agreement, seventy years since the rise of the communists to power in 1948, half a century since the Prague Spring in 1968 or thirty years since the Velvet Revolution in 1989.

The Institute's role as national service provider for the CESSDA ERIC social science data archives infrastructure represents another form of its international cooperation. By operating the Slovak Archive of Social Data (<http://sasd.sav.sk>), the Institute has allowed Slovakia to become a **founding member of the pan-European ESFRI infrastructure in 2017**. In the evaluation period, the archive has seen a gradual expansion of its datasets, driven by actively seeking out early post-1989 public opinion polls as well as via cooperation with public institutions and by including a large volume of its own COVID-19 related surveys. This rise has been accompanied by an increase in the number of data requests, which now amount to a few hundred per year.

Research pursued at the Institute has continued to generate societal impact which has materialized in **large numbers of media appearances and expert evaluations provided by the Institute's members**. From 2016 to 2021, experts from the Institute provided over 600 media appearances including international media outlets such as the Dutch NRC newspaper or the Austrian ORF public television station. As demonstrated by our four case studies, research and expertise provided by the institute have been successful at generating societal impact and public attention.

In this regard, the crisis caused by the **COVID-19 pandemic generated a vivid interest for sociological insights** into societal aspects of the pandemic. The Institute was well-positioned to answer these by forming a partnership with the Institute for Social Communication at SAS and two partners outside of academy (the MNForce research agency and the Seesame communication agency), which allowed the Institute to conduct monthly and bi-monthly surveys in 2020 and 2021 under the title "How are you, Slovakia?" This became a well-established source on general sentiment towards the pandemic, compliance with anti-pandemic measures, and insight regarding COVID-19 vaccine hesitancy in Slovakia. This partnership between two SAS institutes and the non-academic sphere was awarded the Počin roka [Act of the Year] prize in the PROKOP competition organized by the Association of public relations of the Slovak Republic in 2021. This cooperation also formed the basis for organizing the 2021 People and Society in Times of the Pandemic conference. The response to pandemic generated also new demand for expert knowledge of society. Several members of the Institute were invited to join various **governmental advisory committees** and interdisciplinary expert groups.

Last but not least, in the evaluation period, the Institute has participated in a dozen project applications in the Horizon 2020 and Horizon Europe project schemes. Most notably, **three ERC starting grant applications were submitted** (two by core researchers at the institute and one by a SASPRO fellow), with **the most recent application successfully passing step 1 of the evaluation and being currently under evaluation in step 2**. Given the unfavorable situation in Slovakia, where since 2007 only two ERC grants have been awarded to scientists with an affiliation with a Slovak institution and almost no applications pass the first evaluation step, the success of our latest ERC application is a very promising development not only for our Institute, but for science in Slovakia, even beyond the field of sociology and social sciences.

The following most important research outputs are structured by their respective research areas (the post-communist transformation of society, information and education, visual sociology, the sociology of religion, the sociology of finance and economics, and the sociology of migration). See chapter 2.1.2. for the full bibliographic data of these publications.

The largest group of outputs is devoted to the broad issue of **the post-communist transformation of society**.

The book [*Living apart together? Czechia and Slovakia through the lense of value development after 1991.*](#) provides the first systematic comparison of the development of value orientations related to family, work, religion, solidarity, politics and the public sphere in Czechia and Slovakia since the split of the common state. The majority of its chapters are co-authored by Slovak and Czech sociologists who analyze the data from the four European Values Study surveys (1991, 1999, 2008 and 2017) in both countries. The book is important source for wider public reflections on “who we are” and how economic, political and cultural contexts might shape our values.

The book also draws public attention to role of public (political) discourse in the increase of intolerance to foreigners and minorities in all age groups in Czechia and Slovakia as the

2008 - 2017 increase cannot be explained by worsening or uncertainty of living conditions or a decline in education of population.

[Settlement development in Slovakia \(1990-2014\) and its social-spatial contexts and implications](#) is a book by Peter Gajdoš and Katarína Moravanská which analyses the regional and settlement situation in Slovakia between 1990 and 2015. This work builds on the results of projects carried out at the Institute for Sociology in the last 15 to 20 years in the field of regional development. The authors point to diverse socio-spatial processes that have led to current regional disparities. The findings highlight current trends in both differentiating and convergent processes in regional development. Despite some partial counterbalancing of regional differences, the authors identified the types of municipalities and entire regions that most suffer from difficult social and development conditions. The books focus on spatial sociology are among the most cited outputs of the Institute (see section 2.2.3.). References to this work are not only from academic research but can be found also in development and strategic documents of municipalities and regions. This publication has also found application by various government bodies and public administration.

[The Transformation and Fall of Agricultural Cooperatives](#) by Jana Lindbloom is a thorough study of the complex process of the transformation of post-socialist agricultural cooperatives in Slovakia. It recounts the whole period from 1989 to the present. The book's main ambition is to provide detailed answers to the questions of ordinary people (many of them former shareholders) about what actually happened to and in cooperatives. This monograph has been awarded for both its national legacy value (the Slovak Literary Fund Award) as well for its sociological quality (the Award of the Slovak Sociological Society). This study of cooperatives has gained attention both in Slovakia (multiple reviews in scientific journals) and abroad (e.g. a fully funded visiting-scholar stay at the Université Clermont Auvergne in Clermont-Ferrand, France in 2019).

Jozef Zagrapan contributed a chapter to the book [Thirty Years of Political Campaigning in Central and Eastern Europe](#). The text provides an overview of the main characteristics of the political system, electoral laws, and campaign legislation and highlights the most important political events and turning points in eighteen former communist countries of Eastern and Central Europe. It also examines the development and evolution of parties' agendas and strategies, as well as the tools used during political campaigns over the last thirty years – from the first democratic elections in 1990 up to the most recent trends. The book provides a significant contribution to an understudied research area in the region and presents a valuable resource for researchers of political communications and similar fields.

Other studies in the field of post-communist transformation are devoted to the development of science. In the study ["A Content Analysis of Sociológia/Slovak Sociological Review since 1989"](#) Robert Klobucky presents the structure of authors and themes in the main Slovak sociological journal *Sociológia / Slovak Sociological Review* in a temporal perspective. The author notes a large range of metareflection on sociology itself and on some nationally-specific themes like the transformation of the society or the history of Slovak sociology (mostly in the 90's). Recent developments suggest the popularity of other themes including political sociology, the sociology of education or sociological theory.

Miloslav Bahna (with Kamil Luczaj, a visiting scholar at the Institute) examines mechanisms behind the internationalization of Slovak universities in the article ["Explaining the role of international scholars in semi-peripheries. Evidence from Slovakia"](#) published in *Studies in Higher Education*, a top-tier journal in the field. Framing the Slovak academic milieu as a global academic semi-periphery, Bahna and Luczaj find that the growing internationalization of universities in Slovakia can be primarily explained by staff shortages and is occurring mostly at the less-prestigious universities in Slovakia. This adds a new angle to the study of internationalization of tertiary education which is, when studied in the global academic centers, usually connected with academic excellence. The article was awarded a premium by the Slovak Academy of Sciences in 2021.

The second group of studies addresses the **broad issue of (mis)information and education in society**.

The book *Discussing the News: The Uneasy Alliance of Participatory Journalists and the Critical Public* by Simon Smith published by Palgrave Macmillan in 2017 is the outcome of the project "Media-hosted eParticipation in Slovakia", financed by the Marie Curie Intra-European Fellowship. It analyses the new roles that journalists assume in a participatory media environment where online discussions serve as relevant intermediaries in public democratic political participation. This book offers both a profound theoretical and methodological background as well as practical and insightful findings from empirical ethnographic fieldwork conducted in the newsrooms of two daily newspapers – or more precisely, their web portals.

Elżbieta Drazkiewicz is the co-author (with Jaron Haramban) of the study "[What should academics do about conspiracy theories? Moving beyond debunking to better deal with conspiratorial movements, misinformation and post-truth.](#)" The study claims that many people use conspiracy theories to make sense of a changing world and its increasingly complex social structures or socio-political and economic issues. It also explores the different approaches that academics can take in relation to conspiracy theories. This article is an editorial of a special issue in *Journal for Cultural Research*. This issue is not only important because of the urgent topic, but also because it recognises diverse approaches and gives a voice to scholars representing different viewpoints and

various disciplines. Its success is reflected by the fact that the articles in this issue are among the most read in the journal. This research led to a commissioned contribution on studying conspiracy theories by Elżbieta Drazkiewicz in the [World View section of the Nature journal](#).

Jozef Zagrapan is the co-author (with Peter Spáč and Petr Voda) of the study "[Does the freedom of information law increase transparency at the local level? Evidence from a field experiment.](#)" The study, the first of its kind in Slovakia, focuses on the question of whether freedom of information laws increase transparency at the local level. The paper's uniqueness – even compared to similar research in other countries – lies in the fact that it studies all of the municipalities in the country (2927 in Slovakia). Results show that the type of information request influences responses from the municipalities. The highest chance to obtain an answer occurs when the Freedom of Information law is specifically mentioned in the request. These results imply an important lesson for citizens, who should not consider the existence of the FOI Act in a country as an automatic guarantee that public bodies operate in a transparent fashion. The 2018 paper, published in the highly-refereed *Government Information Quarterly*, has 32 citations in Google Scholar thus far.

The book [School is not for Everybody](#) by Zuzana Kusá offers intimate insights on the everyday life of Roma children and children with special educational needs in Slovak schools. It is based on ethnographic observation and in-depth interviews with pupils, teachers, parents and other stakeholders of education collected during the years 2008 – 2015. The book identifies insufficient support of educational inclusion of minority children and a lack of commitment on the part of the educators to cultivate and promote solidarity and equality as principles of interactions among classmates. The book has received a

positive response among experts struggling for improving inclusion in the Slovak education system and serves to strengthen and justify their arguments.

The next group of three texts is devoted to **visual sociology** and **the visible aspects of social life**.

The book [*Sociology of Crisis : Visualising urban austerity*](#) by Myrto Tsilimpounidi demonstrates how sociologists and social scientists must develop new approaches to examine rapid shifts in the social landscape, since crisis is not merely reflected in balance sheets, but is mediated through the imagery of loss, deprivation and increased vectors of marginalisation. A timely engagement with the problem of crisis at a macro-level and in dialogue with the everyday experiences of crisis on a micro-level, this interdisciplinary title appeals to students and scholars interested in sociology, social policy, geography, urban studies and research methods in social science. *Sociology of Crisis* has been listed as a 'leading handbook in the field' in the Routledge 'Advancements of Sociology' series. The publication was awarded the Prize for the Popularisation of Science by the Slovak Academy of Sciences in 2017.

In her study "[Invisible in homes, visible in cities: visibility and dis/empowerment in paid domestic work in London](#)," Zuzana Sekeráková Búriková connects theories related to visibility and social recognition, debates on cities as public places enabling political action, and paid domestic work. The article analyzes how various aspects of being visible or invisible relate to the empowerment, disempowerment, and resistance of paid domestic workers. The article argues that these spaces are interconnected and that their meanings and usages are relational, depending upon each other. On a more abstract level, the material provided demonstrates numerous ways in which both social recognition and (in)visibility intersect and how various actors (i.e. host families and au pairs) actively use visibility and invisibility to achieve their aims. It demonstrates that host families invisibilize au pairs and their work in order to both diminish their role in children's lives and secure the myth of the exclusivity of the nuclear family. Au pairs counter this process of invisibilization by making themselves visible in their rooms and in the city.

Silvia Miháliková in her study "[Inventing an Image for an Unknown Nation? The case of Slovakia](#) [*Ein Image für eine Unbekannte Nation Erfinden? Der Fall Slowakei.*]" argues that Slovakia's place or even the very existence of the Slovak nation in the Central European cultural and intellectual community has been a volatile issue throughout Slovak history. Such a discussion features misuse of arguments derived from history: politicians and intellectuals distort history, enlisting personalities, events and symbols for their own purposes. Arguments derived from different historical periods are used in order to explain and support today's politics, showing who are and always have been our enemies. The performance of ancient and modern history is perceived as a contemporary issue. History is thus used in a horizontal way, for manipulation and even mass mobilisation. In order to shape national memory after 1989, and even more after gaining independence in 1993, the ruling political elite in Slovakia sought to create a convincing popular narrative linking the 'acceptable' past with the reconstructed post-communist state.

The **sociology of religion** is represented by two texts by Miroslav Tížík.

The chapter "[Slovakia as a country without atheism but with a history of atheization](#)," which is part of an edited volume on the history, development and transformations of freethought and atheism in Central and Eastern Europe published by Rutledge, is focused on the particular case of Slovakia in its historical context. Although there have been many secular humanist and freethought associations and movements in Slovak history, and although the state enacted a strong anti-church policy in the period of 1948 – 1989, these did not exert a significant influence on the general religious affiliation of the population. The text focuses on intellectual movements and on the influence of intellectual leaders in the spread of freethought, atheist and humanist thinking in various historical periods.

The article "[Religious Minority as a Source of National and State Identity: The Case of Slovakia](#)," focuses on the analysis of the role of churches and political figures in the creation of the national movement and national mythology. In Slovakia, Lutherans, in spite of making up only a small proportion of the Slovak population, have been one of the two fundamental sources of the national movement in the last two centuries. The article shows how the contemporary character of the state, society, and national identity and its relation to religion is influenced by the bi-confessionalism of the Slovak national movement, which was initiated by Slovak Lutherans in the eighteenth century. Although the Lutheran religious minority has been dwindling since 1990, the article shows how its heritage is still present in the character of contemporary institutions of national tradition and identity.

Two texts in our selection of the most significant results are devoted to the **sociology of finance and economics**.

The chapter "[The Local Counterparts of Financialization: Organizational Accomplishments of Farm/land Investments and Sales](#)" by Jana Lindbloom is a commissioned contribution to an international monograph on the current topic of the financialization of the global economy, in this case, agri-food systems and agricultural land. This monograph, edited by the leading scholars in the area and published in Routledge, is an outcome of discussions at international conferences. The book aims to provide detailed insights into the transformation of farmland relations and the agri-food sector in virtually all continents. The chapter on these developments in Slovakia explains the mechanisms of financial capital entry and the procedures of farm and land acquisitions by domestic, international or institutional financial investors. The intriguing particularities of Slovak circumstances and especially the attempts to legislatively offset the impact of financialization, resulted in an invitation to present the findings at the "Scottish Land Reform in a Global Context: knowledge exchange workshop" organized by the Scottish Land Commission of the Scottish Government and James Hutton Institute in Aberdeen in 2019. Thus, this study helped to shape policies and legislation regarding property relations to land not only in Slovakia but in other countries as well.

The study by Dominik Želinský (with Arjen van der Heide) "['Level up your money game': an analysis of gamification discourse in financial services](#)," deals with how the idea of gamification, or the implementation of game-like elements and mechanisms in non-game contexts, has, throughout the past decade, swept the fields of healthcare and fitness as well as education. More recently, various tech writers, bloggers, and consultants have begun proposing gamification as a solution in financial services as well. For instance, gamification has already made headway through day-trading apps that simplify trading and turn it into a real-time game. The article examines the emerging discourse of financial gamification and situates it within the dynamics of expectations and performative struggles that are shaping technological developments in finance and the FinTech industry. However, despite the promises of financial gamification to democratize finance and empower retail investors by expanding access to financial markets, Želinský argues that the discourse of financial gamification ultimately reinforces the "observational boundaries" between finance and society.

The sociology of migration is represented by two publications by Miloslav Bahna.

Miloslav Bahna is the first author (with Martina Sekulová) of the 2019 book *Crossborder Care : Lessons from Central Europe* published by Palgrave Macmillan. The monograph presents a study of the topic of cross border care between Austria and Slovakia as a special case of the commodification of care. The book has been awarded the status of an outstanding monograph by the Slovak Academy of Sciences and has been awarded in the Alexander Hirner competition for the best sociological work in 2020. The book has been reviewed four times and received considerable media attention at its presentation in early 2019. Bahna has been repeatedly approached as an expert on the topic by scholars and experts from Austria and Hungary and has also participated in an evaluation of training provided to Slovak care workers by the Austrian Chamber of Commerce.

The article "Study choices and returns of international students: On the role of cultural and economic capital of the family" represents the first of a series of articles by Miloslav Bahna on the highly topical issue of international student mobility from Slovakia (a country with the second highest share of tertiary students studying abroad in the OECD). Uniquely connecting information on the students' families, place of study and post-graduation stays and returns two years after graduation, Bahna offers new insights on the role of the cultural and economic capital of student families in post-graduation decision making. This article is one of the most cited 2018 articles of the *Population, Space and Place* journal. Findings from the study were presented in Slovak daily *Dennik N* and are referenced in analyses of the Institute of Education Politics at the Slovak Ministry of Education.

Besides formal cooperation on the PhD study programme with the Department of Sociology of the Faculty of Arts at the Comenius University, we cooperate with the Department also in the Slovak participation in the ISSP and coordinate the operation of the Slovak Archive of Social Data.

2.5.8. Supplementary information and/or comments on doctoral studies and educational activities – focused on what changes have occurred since the last evaluation in 2016

As was already mentioned, the PhD programme at the Institute was re-established only in 2016. Over the course of the evaluation period, we were able to attract strong candidates for the PhD programme. On average, two full-time and one part-time PhD positions were filled every year. Since the re-establishment of the PhD programme, the pool of candidates is becoming larger, even attracting graduates from universities outside of Slovakia. As mentioned above, besides the courses which were part of their study at the partner university, the Institute had provided the PhD students with a series of PhD seminars aimed at writing skills, using reference management applications, advice with preparing manuscripts and data analysis workshops. The recent approval of a new PhD guarantor in

2022, together with the attainment of senior researcher status by three researchers which enables them to become PhD supervisors in 2021 secures a successful continuation of the PhD programme at the Institute.

During the course of the evaluation period, a series of steps was introduced to strengthen the programme. These include a) a series of workshops by researchers from the Institute aimed at building academic skills of our students, b) support in applying in the Doctogrant grant scheme for doctoral students introduced by the SAS in 2019 and c) organizing mock PhD presentations with the aim to provide feedback and strengthen their thesis and its presentation when defending their PhDs

As was already mentioned in part 2.5.3., our first graduates are all able to find employment in positions which are well suited for their qualification obtained in our doctoral programme.

Case study 1: International comparative quantitative research with societal impact
EVS Scientific Tea Rooms 2018 - a series of educational events for secondary school students to promote critical thinking and debate on European values, views on human rights and attitudes to democracy.

As a part of the popularisation of results from the international comparative research project EVS 2017 (EVS - European Values Study) members of the research team presented the results at **a series of educational events called Scientific Tea Rooms - Platform for Democratic Culture**. The Scientific Tea Rooms (ST) project was established as a scientific project of Académia Istropolitana Nova, the Helsinki Committee for Human Rights in Slovakia and the Institute for Sociology of the Slovak Academy of Sciences, bringing together institutions focused on civic education, active civic participation and youth awareness under the spirit of European values based on the traditions of humanism, pluralism, and peace. During 2018 the ST took place **in seven regions in Slovakia with the participation of more than 700 secondary school students and teachers**.

The aim of the ST was to challenge critical thinking, to start discussion among students and to show how Slovak citizens (and Europeans in general) perceive the world around them, how they react to contemporary conflict ideas and issues (value dilemmas) and what ideas and attitudes they prefer when talking about issues related to human values, culture of democracy and human rights.

Students had the opportunity to discuss the topics like democracy benefits, perceptions of tolerance, consequences of migration, globalization, extremism, as well as forms of solidarity and social justice principles. Researchers from the EVS team presented the students the results - the opinion and value preferences in order to explain the broader context of how individuals or larger social groups may differ in their views and attitudes when confronted with value dilemmas in democratic societies.

The discussions aimed to **improve several student's skills like argumentation skills, practice in dealing with controversial topics, insight into our stereotypes and prejudice, respect to others, comparing opinions or formulating conclusions**. An

important part of the presentations was the introduction of survey methodology and the use of time-series empirical data. To better understand these background information students had the opportunity to answer selected questions in the EVS questionnaire themselves - to test their views and attitudes on democracy and related topics. The data are available in **a special report - a sample of 720 secondary school students** from all municipalities in Slovakia. **Data for students' views on democracy were also compared with the results of the general population from the EVS 2017 survey wave.**

Reaching a wider public, the **results of the EVS 2017** were reported and communicated by publishing **regular press releases** using findings from the EVS survey related to the topics of **important international and festive days during 2018** (such as Labour Day, Mother's Day, Children's Day, World Environment Day, etc.). Ten published press releases recorded a **total of 108 downloads/distributions in print electronic (TV and radio) and social media**, as well as several additional public talks about the details of press releases.

Case study 2: Social science expertise supporting the COVID-19 pandemic response

Institute of Sociology actively entered the public discourse on the setting up of measures to cope with the epidemic not only through journalistic and scientific texts, but also through their participation in various expert groups. Expert knowledge was also based on data from several researches initiated by the Institute for Sociology.

Expertise - Since the beginning of the COVID-19 pandemic, the Institute's staff has been involved in interdisciplinary collaborations of scientists in predicting or setting up tools and policies for life during an epidemic. Institute staff collaborated on **pandemic spread modeling** with the **Institute of Mathematics of the Slovak Academy of Sciences** and commented on **pandemic spread models from the Institute of Health Policy (IHP)** of the Ministry of Health of the Slovak Republic. Several Institute staff commented on the system for automatic management of epidemiological measures and their release during a pandemic. As **part of the interdisciplinary initiative "Science Helps (Covid-19)"**, they monitored the development of the epidemic in Slovakia on a daily basis, regularly **commented on the strategies**, documents and measures of the Slovak Government and individual ministries (especially the Ministry of Health, Education and Economy), **provided numerous expert consultations**, formulated their own proposals for the management of the coronavirus pandemic in Slovakia, and published public statements on current epidemic issues. The Institute staff also developed **expertise on testing among at-risk groups**, particularly marginalized Roma communities, and consulted on the setting of research to evaluate the success of the vaccination lottery.

Continuous research - The Institute for Sociology was heavily involved in the continuous research of society in the time of the pandemic **"How are you, Slovakia?"**. This is a series of internet-based representative surveys.

A number of the Institute's staff participated in the development of the questionnaire and collaborated in the **publication of 34 press releases from twelve waves of research carried out in 2020 and 2021**, which are available on the Institute's website. The findings from this series of research have received **considerable media coverage** and have contributed to the **Institute's visibility as a center of social science expertise in relation to the pandemic**. The datasets from these studies are gradually being made available in the Slovak Social Data Archive. Also on the basis of the knowledge gained in this series of studies, several staff members of the Slovak Academy of Sciences have provided the advice and expertise mentioned above. For their participation in this project, the Institute's staff received the **Slovak Academy of Sciences Award for Popularization of Science and Social Applications of Science**.

The Institute of Sociology also conducted a survey in November 2020 on **"Values and Society during the Covid-19 Pandemic"**. The survey focused on exploring topical issues in six thematic areas: social trust, politics and democracy, conspiracy theories, views on vaccination, the environment and leisure. The research was **carried out in the framework of** the international cooperation project **"European Values Study"** and resulted in **three press releases and a publication**. Also on the basis of the findings of this survey, several members of the Institute's staff have provided the advice and expertise mentioned above.

International conference - In 2021, the Institute of Sociology organized **international multidisciplinary online conference "People and Society in Times of the Pandemic"** (in cooperation with the Institute of Social Communication Research of the Slovak Academy of Sciences), which was devoted to various aspects of the impact of the Covid-19 pandemic on society and individuals. The conference featured **25 papers from speakers from four countries** from various international institutions. A book of abstracts was also published from the conference. The conference attracted quite a lot of interest from the general public with approximately **300 online attendees** and also received a good response in the media.

Case study 3: Linking academic research, expertise and popularization of child poverty reduction

Pushing the topic via an interdisciplinary conference - In 2018 Zuzana Kusá reaped the knowledge of her multiyear research of school inclusion and social situation of Roma children (2008 – 2011 and 2014 – 2016) and of ten years of her expert case studies (within the position of national expert DG employment for social inclusion 2004 - 2016) and prepared the concept of the multidisciplinary conference ***Child poverty and Deprivation and their Consequences on Life Chances***. The **conference** was held on June 21, 2018 in Bratislava and with almost **90 participants from social and medical science, central public administration, helping professions, education, etc.** In the conference first part the invited scientists (a) presented the findings of social and medical sciences on the effects of child poverty and deprivation on the cognitive and social progress of children, (b) critically assessed existing measures to reduce child poverty and (c) highlighted the need for stronger public policy intervention in this area. The lectures as well as the next part of the conference comprising the panel discussions representatives of the public administration, the civic sector and academia on the topics of adequate income, adequate housing, early intervention and pre-school education aroused a wide and critical discussion among the conference participants. They finally adopted a [joint statement](#) prepared by the conference program committee which asks responsible bodies and institutions of Slovakia to fulfil more consistently human rights obligations in this area outlined by the commitments and recommendations resulting from the signing the UN Convention on the Rights of the Child, the Treaty of the European Union and the Commission Recommendation of 20 February 2013 Investing in children: a way out of the vicious circle of disadvantage and European Pillar of Social Rights

Agenda Noticed by the Government Program Manifesto - The book ***Behind the sharp borderline*** by Zuzana Kusá, which was published in the same year, comprised the same appeals as the conference and considered barriers and possibilities of solidarity of Slovak public with Roma minority children. This book, the conference as well as the **widely shared**

press release (May 31, 2018) [*Poverty continues to hold up life chances of children of Slovakia*](#) that anticipated the conference, have contributed to the increased **interest of the mass media and the political opposition** to the issues of child poverty and finally **led to much more extensive attention to the fight against child poverty and minority children education in the newly elected Government Program Manifesto** (compared to the previous governments Manifestos).

Advising the president - Thanks to her effort to set the issues of poverty and solidarity on public agenda **Zuzana Kusá** was invited to be a **member of Advisers board of the president of Slovakia** Zuzana Čaputová (2019-2020). She was also awarded by the **S.A.S. Popularisation Price** (2019) and a the **Pelikán Award** for cultivating political and civil dialogue from the Czech magazine Listy. Since 2018 Zuzana Kusá also serves as the member of *Child and Youth Committee* by the Slovak Government Council for Human Rights, ethnic minorities and Gender equality.

Case study 4: Conspiracy theories and the trust relation between the state and its citizens – from inovative research approach with social impact

The initial research interest of Elzbieta Drazkiewicz was on medical trust and the relation between the state and its citizens. She examined medical conspiracy theories and the ways in which they redefine patient-doctor and citizens-public health relations. Specifically, she focused on the reasons behind a 30% drop in the HPV vaccination uptake in Ireland vis-à-vis the 2018 Cervical Check scandal. This scandal concerned a conspiracy within Irish Health Services Executive management to conceal deficiencies with the cervical cancer screening services. Unlike other scholars of conspiracy theories, who focus on knowledge deficiency, her approach saw the growing vaccine hesitancy as a signal of trust deficiency and the deliberating relationship between Irish state, Irish women, and welfare and healthcare industries. The findings of that research resulted in a chapter (co-authored by Dr Drazkiewicz with Prof. Elisa Sobo) in 'Viral Loads' (UCL Press, 2021) – a volume edited by Nancy Burke, Ayo Wahlberg, and Lenore Manderson. It also led to a special issue 'Does truth matter? The role of social sciences and humanities in dealing with conspiracy theories' which Dr Drazkiewicz coedited with dr. Jaron Harambam (VU University Amsterdam), and which appeared in *Journal for Cultural Research*. Most recently dr Drazkiewicz was commissioned by Berghahn books to publish with them a monograph on conspiracy theories. We are also particularly proud that the ground-breaking approach to conspiracy theories exhibited in this project led to the **invited publication in Nature** (*Study Conspiracy theories with Compassion* Nature 603:7903. p.765 <https://www.nature.com/articles/d41586-022-00879-w>).

The innovative approach to the study of conspiracy theories presented by Dr Drazkiewicz has been highly appreciated by the Irish medical community, leading to tight **cooperation with the Health Protection and Surveillance Centre in Dublin** (2018). On several

occasions, she was invited to give talks to the members of the HPSC and National Immunisation Office and inform their practice. She was also a guest speaker at the most prestigious Scientific Meeting of the Public Health Department of the **Royal College of Surgeons** in Ireland. In November 2021 she was invited to provide an expert statement at **the British Parliament, All-Party Parliamentary Group on Artificial Intelligence**.

The commercial partners agreed to the philosophy of making all survey data produced in this collaboration freely available for secondary analysis via the Slovak Archive of Social Data.

The presented activities are only **a small sample** of the **almost 700 documented activities** (see table 2.7.2. below) and of further **numerous minor media** mentions (e. g. short comments on TV and radio or quotes in newspaper articles) of research and researchers at the Institute which are not documented.

Press release series

"How are you, Slovakia?" - A series of 34 press releases based on results from the research series "How are you, Slovakia?" on society in the time of the pandemic, includes press releases from twelve waves of research carried out in 2020 and 2021, all press releases are available on the Institute's website.

"European Values Study" - A series of 11 press releases based on results from the research "European Values Study" devoted to the issue of different values in Slovakia. Press releases were published between 2017 and 2019 and are all available on the Institute's website.

"International Social Survey Programme (ISSP)" - Eight press releases published from different rounds of the ISSP survey (2017-2021) on topics such as work, trust, corruption, etc. All press releases are available on the Institute's website.

"Values and Society during the Covid-19 Pandemic" - Three press releases (2020-2021) from the survey "Values and Society during the Covid-19 Pandemic", all press releases are available on the Institute's website.

Slovak Archive of Social Data - National service provider of the CESSDA ERIC

The institute maintains the Slovak Archive of Social Data (<http://sasd.sav.sk>), an archive, which is a service provider of the **CESSDA ERIC infrastructure**, in which **Slovakia became a founding member in 2017**, when CESSDA was established in the legal form of an ERIC infrastructure. The archive has been in operation since 2005 and provides access to data files from – mostly representative – surveys carried out in Slovakia in the period from 1968 to 2021. Currently (2021), the archive hosts 74 data files. **Between 2016 and 2021, the archive provided data files for secondary analysis to 1878 users.** Users of the SASD include academics, researchers, students of sociology and related disciplines, and foreign experts on Slovakia and Central Europe.

The archive plays also an important role in enhancing the level and standardization of survey documentation. It also serves as a survey question database, enhancing the replicability and comparability of surveys in Slovakia. (Data from all rounds of the ISSP and EVS surveys are available from the archive as well as the pandemic survey series “How are you, Slovakia?”) The archive is also in active cooperation with existing research projects at the Institute which supplement the limited funding of ERIC infrastructures on the state level which currently covers only membership fees and travel expenditures. Other running costs are covered from the budget of the Institute. In the evaluation period, the archive participated in several internal

CESSDA work plan projects and is planning to apply for the Core trust seal certified trustworthy data repository certification.

The library of the Institute with an online catalogue

The Institute's library has an online catalogue of its approximately 10 thousand library items. Besides serving the internal scientific community of the Institute and the Academy, it has provided its library services to dozens of researchers and students outside of SAS.

Preparatory work on digitized qualitative data archive

During 2019 - 2021 basic work was carried out in building an archive of qualitative data, which will be part of the Slovak Social Data Archive after completion and fulfilment of the required

documentation and ethical standards. We have processed (digitized and arranged) materials from the three qualitative research projects: the letter poll *Common knowledge* conducted in 1990 (more than 200 letters containing authentic experience of the events of the Velvet Revolution 1989), to catalogue accompanying written documents; digitized audio recordings of life history narratives and ensured their literal transcripts from the two qualitative projects *the 20th century in families of Slovak intelligence* (1992-1993) and *Social History of Poverty* (1995-1997) and arranged written documents from these projects. Data corpora from the projects have been created in the Atlas.ti software program, which are currently available in internal operation and used in PhD doctoral research.

2.9. Supplementary information and/or comments on all items 2.1 – 2.8 (max. 2 pages in total for the whole section)

The Institute supports open access publication and research data sharing. All articles in the flagship journal of the Institute - *Sociológia* are published in the platinum open-access model where publication costs are fully covered by the Institute and no costs are covered by the author.

All research data produced by the Institute is made available via the Slovak Archive of Social Data. This includes also data produced within the “How are you, Slovakia?” survey series where the Institute cooperates also with partners outside of the Academia.

The Institute supports also the access of the public to public opinion polls results and was the first to issue a public statement against a law prohibiting publication of electoral survey results 50 days prior to parliamentary elections approved by the Slovak parliament in 2019 (<http://sociologia.sav.sk/podujatia.php?id=3108>). This law was deemed unconstitutional in 2021 by the Slovak Constitutional Court.

3. Implementation of the recommendations from the previous evaluation period

The overall evaluation from the previous assessment period was generally favorable, awarding the Institute the status of a “B” institute assigned a special mention, being one of the three institutes evaluated as “B+” from the social sciences and humanities section of SAS.

The review from the 2012 – 2015 evaluation period provided the following recommendations which were addressed in the institute action plan adopted in 2017:

Comments and recommendations for further improvement of the institute

“It is advisable not to broaden the portfolio, as is suggested in the strategic part of the report; in fact, the opposite would be desirable. Stronger strategic thinking would result in one or two flagship projects around which long-term interinstitutional collaborations could be built with frequent mutual exchanges of students and visiting scholars.

The Institute may want to invest more in H2020 applications: ERC and Societal Challenges included. More efforts to organize international conferences are advisable.”

Research portfolio and strategic collaborations

The call for a flagship project was implemented by the APVV-supported HODYSE project, which focused on the European Values Study and brought together a large part of the research capacities of the Institute. Another example is the long-term cooperation on the ISSP comparative survey series with the department of Sociology at the Faculty of Arts of Comenius university. The overall aim is to build teams around large projects which will focus either on international comparative research or

on topics where a considerable amount of expertise within the Institute can be mobilized.

In addition to these projects, we approached the call for a **concentration of effort and a clear research focus** in the previous evaluation via three strategies. The first is **our PhD programme**, established at the beginning of the current evaluation period, which enables strong scientific personalities from the Institute to establish or strengthen their research teams. This has been successfully applied in several current projects with active PhD student participation. The second strategy involves **creating post-doctoral positions in large national projects** supported by the national grant agency (APVV). These post-docs strengthen the personnel capacities of the project teams and help create synergies. A third strategy is a general **push towards more collaborative authorship**. A growing share of the Institute's output is co-authored, with multiple authors from the Institute.

Fostering inter-institutional cooperation, the Institute has become a member of the European Consortium for Sociological Research (<https://ecsrnet.eu/>), which is a professional organization of leading institutions in the field of sociology that promotes theoretically driven empirical research. Establishing cooperation with academic organisations in other neighboring countries and further abroad, the Institute has joined a six-party agreement between the Institute of Sociology of the Chinese Academy of Sciences in Peking, the Institute of Sociology at the Center of Social Sciences of the Hungarian Academy of Sciences in Budapest, the Institute for Philosophy and Sociology at the Polish Academy of Sciences in Warsaw, the Institute for Philosophy and Sociology of the Bulgarian Academy of Sciences in Sophia, and the Institute of Sociology of the Czech Academy of Sciences. Cooperation with our Czech partners is based also on a separate cooperation agreement between the Institute and the Institute of Sociology of the Czech Academy of Sciences and is supported by a mutual presence in various academic management bodies (accreditation committees, steering committee and international advisory board) and mutual editorial board membership in the *Sociológia* and *Sociologický časopis – Czech Sociological Review* journals.

Horizon and ERC applications

The institute has been very active in participating in projects submitted under the Horizon programme. In the evaluation period, the Institute **participated in 12 project proposals**. Compared to the previous evaluation period, researchers from the Institute actively participated in a few new COST project proposals and are active in several ongoing COST projects, some as Management committee members.

The Institute has also been very active in preparing ERC project proposals. Two proposals were submitted in the 2017 and 2018 StG calls – one by core staff member and one by a SASPRO fellow. One proposal has been submitted in the 2022 StG call, which **successfully passed phase 1 evaluation**. The PI was **invited for interview** in September 2022. This is an extremely promising result, as projects from the CEE region, particularly from Slovakia, tend to be very unsuccessful in the first evaluation phase.

International conferences

With regard to international conferences (co)organized by the Institute, the list of conferences in the previous assessment period included three conferences. The current list is notably more extensive.

Several of these conferences also had a **strong presence of researchers beyond the CEE region** - a notable example being the General Assembly of the ISSP programme, which was held in June 2022 in Bratislava and included over 60 social scientists from 40 countries around the world.

4. Research strategy and future development of the institute for the next five years (Recommended 3 pages, max. 5 pages)

Research strategy of the institute in the national and international contexts, objectives, and methods (including the information on when the strategy was adopted)

The starting position of the Institute in the current evaluation period of 2016 to 2021 was rather favorable. The Institute had re-established its position as a provider of PhD studies in 2015 (in collaboration with the Department of Sociology at the Faculty of Arts of Comenius University) and admitted its first students in 2016. Also, it had been evaluated quite favorably in the 2012 - 2015 SAS evaluation which was made public in early 2017.

In the evaluated period, many of the positive developments from the previous period were developed further. The Institute joined the consortium of leading research institutions in sociology in Europe (European Consortium for Sociological Research, <https://ecsrnet.eu>) and became a founding member (representing Slovakia) of the CESSDA ERIC, founded in 2017 in Norway. Following a recommendation from the evaluation, an International Advisory Board has been established at the Institute.

Supported by three major national APVV grants, efforts in collaborative comparative research programmes have continued to place the Institute on the map of European sociology. Research team from the Institute was actively participating in all European Values Study (EVS) project network activities and joint projects, and is currently involved in the preparation of the next, sixth wave of the EVS survey in 2026. The Institute has taken an even stronger and more active role in the development of research topics for the 2022 (Family and Changing gender roles) and 2023 (National identity and Citizenship) ISSP modules and in organizing meetings, such as the ISSP DG 2022 meeting in 2020 and the **General Assembly of the ISSP programme, which was held in June 2022 in Bratislava** and included over 60 social scientists from 40 countries around the world. The Institute has also been more active with regard to international conferences (co)organized by the Institute (see part 2.3.2.).

The Institute was among the first in the area of social sciences and humanities at SAS to recognize the potential of the ERC grant scheme. With three applications submitted in 2016, 2017 and 2021, it is perhaps also the most active in this regard among the social sciences at the Academy. Most importantly, the most **recent application has successfully passed step 1 of the evaluation in the ERC** which is already an extraordinary achievement as Slovakia has a very low success rate in ERC projects. In fact, it is the worst in the EU. Success in the ERC competition has therefore become a matter of general prestige for the whole science system in Slovakia, which we, as a nationally leading Institute, consider our responsibility to help attain. Besides preparing project proposals, we also maintain active contact with ongoing ERC projects since two researchers from the Institute had post-doc positions in ERC projects and one research fellow is a member of the advisory board of one ERC project and serves as an independent ethics advisor in another.

The Institute has continued to focus on research quality by substantially increasing its output in the most selective peer-reviewed journals. This can be seen either by the simple metric of IF quartiles, where publications from the Institute form a disproportionately large share of Q1 publications in the overall output of the social sciences and humanities at SAS or by the Norwegian Register for Scientific Journals, Series and Publishers (the so called "Nordic list" https://kanalregister.hkdir.no/publiseringskanaler/Forside?request_locale=en) – a journal metric based on peer review panels developed by the Norwegian Directorate for Higher Education and Skills and used by the SAS to identify excellent publications in the social sciences and humanities where the application of simple citation-based metrics is rather limited. Authors from the Institute have repeatedly **published in journals identified as being among the top 20% in their field** ("level two" journals in the Nordic list). Our publications have tended to be more frequently published in selective publication outlets as time goes on, so there are even more of those articles towards the

end of the evaluation period. The same tendency is true for book publications. In the evaluation period, several monographs at leading scientific publishers were published. A transfer of know-how from the two SASPRO scholars who published their monographs while at the Institute was an important aspect of this development which helped other authors from the Institute to prepare a well-evaluated book proposal. **Publications** from the Institute were **awarded several prizes** by the Academy as well as other institutions.

Beyond doing research, publishing and supervising students in our own PhD programme at the Academy, researchers from the Institute were involved in teaching courses at several universities in Slovakia, in the Czech Republic, and Austria. Our faculty members are editors or editorial board members of numerous international journals (*Central and Eastern European Migration Review*, *New Perspectives*, *Irish Journal of Anthropology*, *Religion and Society in Central and Eastern Europe*, *Sociologický Časopis*, and *Biograf*). They are also active in providing **expertise to governmental and public institutions** in Slovakia and beyond. These include expert statements at the All-Party Parliamentary Group on Artificial Intelligence of the British Parliament and the Scottish Land Commission of the Scottish Government. Our researchers also served as policy advisors during the COVID-19 pandemic (see case study in part 2.6.1.).

The institute continues to **excel in popularization**, extending its media presence via even more numerous media appearances than in the previous evaluation period. Several researchers write op-eds for national newspapers in Slovakia, and three researchers have a regular column in major national newspapers. Through our strong media presence, including a **commissioned commentary** for the World View column in the *Nature journal*, the period of the pandemic became a well-used opportunity to generate societal impact. In the evaluation period, three Academy popularization prizes were awarded to researchers from the Institute. The Institute also has an active social media presence with a solid pool of followers.

Personal politics and internationalization

The rightly identified need for rejuvenation of the Institute noticed by the previous evaluation board was addressed via a **series of new openings** which were advertised through EURAXESS and widely circulated via our professional networks and social media. This **attracted strong candidates** who were typically graduates from top ranking universities (i. e. Cambridge university, the University of Edinburgh and Tilburg University) or had gained research experience abroad in ERC financed post-doctoral positions. This has also paved the road to the internationalization of the Institute, as two of the newly admitted researchers are foreign nationals from Poland and the Czech Republic. Three junior researchers employed in the evaluation period were successful in obtaining the SAS Stefan Schwarz stipend for attracting post-doctoral researchers, which is awarded on a competitive basis. One junior researcher placed second in the SAS prize for talented scholars under 35.

Another avenue for staff recruitment was through **project-based post-doctoral positions** which were **opened in 2016 and 2020** by major APVV projects involved in comparative research. Overall, these openings brought a welcome decline in the average age of the research staff and also more disciplinary diversity by opening the Institute to trained social anthropologists and political scientists.

A similar effort was aimed at attracting strong candidates for the PhD programme. Every year, the Institute was able to fill on average one part-time and two full-time PhD positions. Generally, the **pool of candidates became larger** and also **attracted graduates from universities outside of Slovakia**. Besides the courses which were part of their study at our partner university, the Institute provided the PhD students with a series of seminars aimed at writing skills, using reference management applications, preparing manuscripts, and data analysis. The recent **approval of a new PhD guarantor**, together with the attainment of senior researcher status by three researchers, which enables them to become PhD supervisors, secures the continuation of the PhD programme at the Institute.

Part of the personnel policy of the Institute was to keep ties with older generations of researchers retiring from the institute. Therefore, an emeritus researcher status was established and awarded to several of the former senior research fellows at the Institute.

With regard to personnel, the Institute grew by more than three full time equivalent research positions from 18.2 in 2019 to 21.3 in 2021. This was accompanied by an adaptation of two new office spaces for permanent and temporary work at the Institute's premises.

Future development

The plan for the coming years is to continue in what we perceive as a rather favorable development with regard to scientific quality and research impact. We see further potential in internationalizing our PhD study programme by forming co-tutelle agreements with our partners in neighboring countries or with partners in the ECSR consortium. In 2022, we began a programme of **mock PhD defenses** to provide feedback and prepare the presentations of our PhD students who are finalizing their theses for submission.

The existing know-how in global academic publishing, the advice of the International Advisory Board of the Institute, the scientific cooperation, mutual exchange of ideas and feedback via a series of work in progress seminars, as well as a **growing share of co-authored works** are all tools which we believe can create synergies and inspire solid research with societal impact at the Institute. To increase our success at publishing in the most selective outlets, we plan to introduce and support reading programmes: **all prospective research outputs will be read or discussed before they are submitted** to a journal by a colleague of similar expertise.

With regard to personnel development and performance monitoring, we plan to continue conducting well-established annual performance evaluations, which take into an account performance in the current year and a two-year rolling average of research performance points, and 5 years personal evaluations providing more qualitative insights and career advice to individual researchers. The recent development regarding our latest ERC project proposal is very encouraging, but there are **more strong candidates** with a solid research portfolio and CV **which plan to seek ERC funding** in the near future.

Special **incentives for the participation** of core researchers from the Institute **in short and medium terms research stays** (e.g. Fulbright stipends or Marie Skłodowska-Curie Actions) will be contemplated to increase the outward mobility of staff and further foster international cooperation. In parallel, we plan to continue **welcoming researchers** interested in coming to work at the Institute **via various incoming schemes**. We also plan to continue in developing research partnerships, both with other institutes at the SAS and outside of the academy, which we established in the times of the pandemic.
