It is with great pleasure that the Scientific Committee of the Belgian Federal Agency for the Safety of the Food Chain announces its upcoming 10<sup>th</sup> symposium which will focus on **'Improving the safety of the food chain through risk prevention in plant and animal production'**. The symposium will take place on the **28<sup>th</sup> of November 2014 in Brussels** (Auditorium Pacheco, Pachecolaan 13, 1000 Brussels).

Starting from the application of a similar risk assessment approach in the plant and animal production sectors, the symposium will tackle the challenges of the development of an effective risk prevention strategy in order to improve the safety of the food chain (and in particular food safety). The program of the symposium is specially designed to attract risk assessors, risk managers, decision makers, stakeholders and consumers. Hereafter you can find the definitive program.

Participants will be invited beforehand to respond to a survey on "Stakeholders perception and attitude towards risk prevention in plant and animal production". The goal is to obtain more insight about this topic. The results will be presented during the symposium. The symposium will be concluded by a debate between risk managers, risk assessors and stakeholders of the food chain.

Presentations during the symposium will be given in English. Simultaneous translation in Dutch and in French is foreseen. The symposium takes place in the Pacheco auditorium of the Finance tower (Pachecolaan 13, 1000 Brussels) and starts at 9:30 a.m.
